as the *Arizona Republic*," Linn says. "I'm also looking into PR because I love the aspect of working with companies and making them sound great.

"I've always liked to write. When I was little, I spent hours lying on the floor of my room writing short stories, simple little stories about someone who lost their dog. I never thought about journalism because I thought it would be boring. But once I got into high school and started getting active on the school's newspaper, that all changed. I enjoyed being able to talk to different people and feeding on their passions and writing about it," adds the Phoenix native.

Linn recently won the 2012 essay contest of the Society of Professional Journalists Arizona. She earned a 3.7 GPA and was the school's Student of the Month in November 2011.

She has been accepted into the Walter Cronkite School of Journalism and Mass Communications at Arizona State University, and has attended both the ASU-Arizona Interscholastic Press Association's High School Summer Journalism Institute and the University of Arizona's Journalism Diversity Workshop. This year, Linn will participate in the AIPA program for the fifth time. She has taken classes in news writing and design, and this summer will assist advisors to create presentations and monitor classes.

Linn has worked on her school's student newspaper, *The Challenge*, for four years, most recently as news editor/reporter, previously as business manager. She was a member of the Quill and Scroll Honor Society, and played flute and piccolo in the school marching band all four years.

Linn also has been a member of her school's chapter of the business-oriented Distributive Education Club of America (DECA), and in her junior year working with two other students on an advertising campaign that promoted Google, a project that qualified for the international competition. She also has been actively involved in Girl Scouts for 13 years and currently is completing the Gold Award.

"I'm honored to have won the scholarship, and truly appreciate it, and I will stay in touch," Linn says. "My mom's been extremely supportive of whatever I wanted to do and is my biggest advocate."

Warneka discusses lawsuit avoidance at state conference


Friting and the Law: How to Write Your Best Seller Without Being Sued." was presented by APW President Brenda Warneka at the state conference on May 19.

Warneka, a lawyer and writer, stated the material she presented applies generally to writers and journalists. However, those who write best-selling books are the ones most likely to be sued because their work gets wide attention, and they and their publishers are thought to have "deep pockets" from which to pay a judgment.

The most popular area for litigation against writers is copyright infringement. Some of the litigation she discussed in this area included cases against Alex Haley for his Pulitzer prize winning book *Roots: The Saga of an American Family* (1976), Stephen King for his best-selling novel *Duma Key* (2008), and Elisabeth Hasselbeck for her nonfiction book about celiac disease, *The G Free Diet* (2011).

Other recent lawsuits against authors have involved class actions over books marketed as nonfiction, but which were claimed not to be true and lawsuits based on the people or characters in the author's book.


